

# REPORT on the activities of the National Institute of Criminology (OKRI) in 2016

## **I. UTILISATION OF RESEARCH RESULTS**

Considerable attention was devoted to the utilisation of research results in this reporting period as well. Areas for the utilisation of results include cooperation in theoretical development, and the representation of research results in educational activities – in development training courses for staff and drafters from the Prosecutor's Office, university and college education and postgraduate training courses – as well as at conferences and other professional events. Our research results also assisted our involvement on request in the codification and statutory interpretation activities of the Prosecutor General's Office. Our researchers have published in and worked as editors or proofreaders for several professional journals. Their active involvement in scientific organisations is also a significant factor. Our researchers expressing their views in the media also played an important role in informing the public by presenting our results, approaches and opinions to broad circles in the course of the current year.

### **1. Presentations**

In 2016, researchers from the Institute delivered a total of **107 presentations** at various conferences and professional forums. Of these presentations, **29** were delivered **in a foreign language** and **20** were **abroad**.

Requests **to chair sessions** also indicate professional recognition and presume professional skills. In the year of the report, researchers from the Institute were requested to chair sessions on **11 occasions**, with **8 out of them at conferences held in foreign languages**.

### **2. Publications**

In the current year, researchers published a total of **123 publications, 15 of them in a foreign language**. Of the latter, **11** were published **abroad**.

This year, OKRI's researchers published **36 chapters in books** and **7 monographs** (books, notes), and were authors of studies published in **36 scientific periodicals** and **16 conference publications**. In addition, **9 papers** were published in publications of the Institute, as well as **15 studies on other platforms (abstract, beyond the website of the institute, other web interfaces etc.)**, and our colleagues were asked **9 times** to **edit** various professional volumes. It is an increasingly characteristic phenomenon that some parts of professional periodicals are not published in a printed form: they are only available on the world wide web. It is therefore fortunate that researchers from the Institute also exploit the flexible publication opportunities provided by the internet.

# II. DOMESTIC AND FOREIGN RELATIONS

## 1. OKRI's domestic relations

The Hungarian relations of the Institute were generally similar to those of previous years. The application of the focus group qualitative research methodology also strengthened our professional relations in the reporting year by virtue of establishing direct working relations with external professional operators.

A professional cooperation agreement initiated in 2014 continued this year also with the Institute of Legal Studies of the Centre of Social Sciences of the Hungarian Academy of Sciences (MTA TK JTI); preparatory work (editing, correction) has been prepared for the conference publication publishing the results of a joint series of conferences from last year and the year prior, and the volume is expected to be released next year.

Cooperation was the closest again with the Prosecutor General's Office and with the prosecution apparatus in general. This year, the Prosecutor's Office initiated more than one third (34.2%, 13 tasks) of all projects in the process. Of the work plan projects, 8 were initiated by the Prosecutor's Office (three by the Prosecutor General's Office and five by the county Prosecutor's Offices), two by the Scientific Council and one by the Ministry of Justice. Five additional tasks were performed on request by the Prosecutor General's Office during the year, in addition to the work plan and the research conducted alongside the work plan.

Our researchers traditionally participate in the work of higher education institutions; many of them hold university positions.

In 2016, researchers participated in domestic conferences, round table or professional discussions, on **87 occasions** where they delivered **presentations** on special request, and on a further **105 occasions** where they attended domestic and foreign conferences **without delivering a presentation**.

## 2. OKRI's international relations

International relations play an important role in the life of research institutes. International relations provide researchers with feedback, and it also helps to evaluate OKRI's research activities, considering that invitations to take part in international projects, joint applications, or offers to publish in renowned international professional magazines all imply that the international scientific community continuously evaluates OKRI's research activities and professional accomplishments.

OKRI's researchers delivered **20 presentations abroad** at conferences, workshops or expert discussions. At the same time, a total of **29 occasions** involved presentations held in a **foreign language**. On 6 other occasions, participants attended foreign conferences without delivering a presentation. Conference participations were covered in part by the Prosecutor General's Office, the researcher's grants and other funds, and in part financed by the inviting party.

The Institute is a research location with traditionally good international relations. One of the Institute's oldest and best functioning relations is with the *Max Planck Institute* of Freiburg, with which the exchange of experience and information and the organisation of joint conferences has been ongoing for decades. In addition, the MPI has in many cases received OKRI researchers as grant holders. In the current year, two institute researchers were awarded research grants to the MDI and another researcher was a scholar at the Goethe Institute in Frankfurt.

### **III. LIBRARY**

The library stocks consists of 9,118 inventory units.

In 2016 the library stock increased by 124 volumes, of which 40 were received as gifts or in exchange. Of the 124 volumes, 40 are in foreign languages, primarily in English.

Exchanging and gifts are important sources for our collection. We consider it important to maintain good relations with libraries collecting books from similar sources. Of the exchange partners, there is outstanding cooperation with the libraries of the Max Planck Institute of Freiburg, the Pázmány Péter

Catholic University, the University of Miskolc and the National University of Public Services, Faculty of Policing Studies, but from this year an exchange relationship was formed with the Library of the Centre for Social Sciences of the Hungarian Academy of Sciences.

This year, a verbal agreement was reached with the Parliamentary Library, in which the library undertook that its specialists will provide continuous information on a specific field, and traditional and electronic information sources related to thematic topics on domestic and international online databases. Within the context of this service, the contents of current foreign curricula, selected by us, are sent electronically, which allows researchers to find out about the newly published literature.

- each of our researchers has an individual personalised interface where they can update their particulars, post their studies, and disclose other information;
- our publications promoted in a special section;
- insights provided into the life of the Institute; news is supplemented with photos of memorable events;
- with key data we assist in producing more specific searches, as well as enhancing hits through international search engines;
- the English version of the homepage that assists foreigners in browsing;
- both in Hungary and internationally, in partnership with partner sites, there are more and more external links to the website of our Institute, therefore we also publish website access to many organisations and institutions in the "Useful links" section.

Following the updates, the renewed website is user-friendly, informative and its appearance is worthy of a European level research institute.
