

REPORT on the activities of the National Institute of Criminology (OKRI) in 2014

I. UTILISATION OF RESEARCH RESULTS

A significant element of the work conducted in the Institution is to utilise research findings, which we focused on in the reporting period as well. These research findings are utilised in establishing theories, and in the training materials of framers and secretaries, in university and college coursework and in postgraduate coursework. Our research findings also helped our participation in the codification and legal interpretation activities requested by the General Prosecutor's Office. The professional prestige of the researchers increased as authors, editors and reviewers in journals, and it also improved the professional preparedness and reputation of the scientific organisations. With the interviews given to various media, our researchers communicated our findings, approach and opinion, and played an important part in informing the general public.

1. Presentations

The researchers of the Institute delivered **125 lectures** at various conferences and professional forums in 2014. Of those lectures, **33 were presented in a foreign language and 24 were abroad**.

In recognition of our professional qualities, our members have been asked to organise **conference sections**. In the reporting year, researchers of the institute were requested to organise sections **15 times, three of them at conferences in foreign languages**.

2. Publications

In the year under review, researchers published a total of **143 publications, 20 of these in a foreign language**. Of those **20, 14** were published abroad. The tendency to increase the number of publications continued this year: researchers of the institute published 44% more scientific communications than the year before, mostly due to an increase in domestic (83) and online (46) publications.

This year OKRI researchers have published **4monographs** (books, notes), **24book chapters**, and also published in **38 journals** and **8conference publications**. In addition, **38 essays** were published in two publication of the Institute (*Kriminológiai Tanulmányok* and *Pusztai emlékkötet*) and in **20 other sources** (*abstract, billboard, websites other than the home page of the institution, etc.*), and our staff members have been asked to act as *editors* of **11** various professional volumes. It is becoming a trend that some of the journals are not published in printed format but only electronically. It is, therefore, fortunate that the researchers of the institute take advantage of the flexible publication opportunities offered by the Internet.

3. Involvement in domestic and international project and professional cooperation

We submitted **5 research proposals** in the reporting year. Some of those targeted Hungarian research funds, some others were submitted as a consortium member with foreign partners to various EU research programmes.

Researchers of the Institute have also taken an active part in the **training activities of the public prosecutor**. We have delivered lectures eight times as part of the training for the prosecutor's framers, MÜK advanced training and professional forums.

6. Media appearances

Our records indicate that researchers of the Institute were registered as experts **187** times in the print and electronic media in 2014.

II. DOMESTIC AND FOREIGN RELATIONS

Professional contacts in Hungary and abroad are illustrated by attending various conferences, presenting at Hungarian and international conferences, teaching, offices and memberships held in various organisations and participation.

1. OKRI's domestic relations

The Hungarian relations of the Institute were similar to those in previous years in general. Through direct working relationship with outside professional participants, application of the target group-based qualitative research method continued to foster our professional relationships in the reporting year.

Our institute concluded a professional cooperation agreement with the Institute for Legal Studies of the Centre for Social Sciences of the Hungarian Academy of Sciences. As part of that cooperation, we have organised and held three scientific sessions this year.

We continue to cooperate the most closely with the General Prosecutor's Office and with the prosecutor apparatus in general. This year we have conducted five working plan research projects based on direct initiatives of the General Prosecutor's Office, and prepared two additional working material at the request of the General Prosecutor's Office received in mid-year, plus we conducted six research projects at the initiative of the county offices of the Prosecutor General.

Our researchers traditionally participate in the work of academic institutions and many of them hold university titles.

In 2014 our researchers attended conferences, roundtable or professional discussions **101 times** where they **delivered lectures** upon request, and they attended Hungarian and foreign conferences **204 times without delivering lectures**.

2. OKRI's international relations

International relations play an important role in the life of research institutes. Researchers receive feedback on their work via international contacts and these also help assessing OKRI's research activity as invitations to international projects, joint proposals, and publication opportunities in

prestigious international journals all indicate that the international scientific community appreciates OKRI's research activity and professional achievements.

OKRI researchers delivered **24 lectures abroad** at conferences, workshops and expert meetings. They delivered lectures **in foreign languages 33 times**. They attended 7 international conferences without delivering lectures. The finances of most of the conferences were covered from tender money or other resources, or were financed by the inviting party, but the General Prosecutor's Office also provided funding for participation at foreign conferences a number of times.

The Institute is a research site with traditionally good international relations. One of the oldest and best operating relationship is with the *Max Planck Institute* of Freiburg, with decades old experience sharing and information exchange, joint organisation of conferences, and MPI providing *research grants* to a number of OKRI researchers on their campus. In the reporting year, *Ferenc Irk* was invited by the Max Planck Institute as a *research fellow*.

Katalin Parti won the Fulbright research scholarship and spent one year at the Massachusetts Aggression Reduction Centre in Boston, USA. As a result of that professional relationship, Meghan McCoy, an instructor at Boston University, delivered a lecture at the Institute on the preventive programmes against school bullying currently in progress in the State of Massachusetts.

Tünde Barabás delivered a report speech to the members of the prosecutor delegation from Mongolia at the General Prosecutor's Office.

Three of our researchers (Pétra Bárd, Judit Szabó and György Virág) summarised OKRI's research activities and Hungarian criminology to Norwegian criminology students visiting the Institute.

In November, we organised a conference and workshop entitled "Potentials in Peacemaking" with attendees from eleven countries.

III. LIBRARY INFORMATION

The library currently has 8853 inventory units.

Between January and 24 November 2014, the library collection expanded with 130 new volumes, 44 of which were gifts or arrived by exchange. 18 of the 130 volumes were foreign, mostly English language publications.

Beginning this year, a computer installed in the library can be used to access *Hatályos Magyar Jogsabályok*, an electronic collection of over 350 Hungarian laws currently in effect, the operative part of over 120 decisions by the Hungarian Supreme Court, over 100 statements of the Supreme Court, brief summaries of over 120 decisions of the Competition Council in three languages, and international accords in English.

As the collection is mostly enriched via exchange and gifts, maintaining good relations with libraries with similar collections is very important. Cooperation with Max Planck Institute, Pázmány Péter Catholic University, Miskolc University, the Curia and the Library of the Law Enforcement Faculty of the National University of Public Service is exceptionally smooth.

In 2014 close to 40 volumes became available to researchers through interlibrary loans.

In January, bibliographical records were converted from the KisTéka system to the integrated library system of HunTéka. As a result of this process, we were able to standardise our system of subject words to simplify searches in the catalogue. However, a few records were damaged during the conversion and these will be repaired during this year. Any errors found in the meantime are corrected on a continuous basis.

We still have a mutual assistance network in place with the General Prosecutor's Office of the Prosecutor General of Hungary, the Office of the Prosecutor General of Budapest, the Office of the Commissioner for Fundamental Rights, the Curia and the library of the Law Enforcement Faculty of the National University of Public Service.

VII. HOMEPAGE

Our website is updated continuously. The administration interface is managed by the staff of the Department of Research Organisation, Documentation and International Relations. Our state-of-the-art web interface, updated on a weekly basis, is currently available to all viewers. Here:

- information is provided on an ongoing basis on current domestic and international programmes (Events);
- each of our researchers has an individual personalised interface where they can update their particulars, post their studies and disclose other information;
- our publications are promoted in a separate section recommending literature (Book recommendations);
- insights are provided into the life of the Institute; news is supplemented by photos of memorable events (Current issues at the Institute, Gallery);
- parties interested are assisted by software and other solutions (Publications, Library software), as well as by key data to enhance hits by international search engines (Google, Yahoo, MSNBot etc.);
- the English version of the homepage assists foreigners in browsing;
- in cooperation with an increasing number of partnering pages, many external links point to the homepage of our Institute (e.g. www.mklu.hu; www.police.hu; www.bvop.hu; www.bunmegelozes.hu; www.cepol.europa.eu; www.kozlekedesbiztonsag.lap.hu; www.render.lap.hu; www.kriminologia.hu; www.kriminalexpo.hu etc.);
- our annual publication titled Criminology Studies is fully available at our homepage, in an electronic version as well.
- our repertory was extended from 2012 by the category of “E-books”: thus, visitors can read unabridged previous publications by our researchers in an electronic format

This year all electronically available volumes of the *Kriminológiai Tanulmányok*, a publication by our Institute that celebrated its 50th issue last year, were published on the website, which means that, from issue 39 published in 2002 to issue 51 published this year, the full texts of all studies are available online (with protection against copying to ensure copyright protection).

Navigating through the series of studies is now facilitated by the online tool **Kriminológiai Tanulmányok Repertórium**, which includes all authors and study titles since 1962.

According to the positive feedback, our homepage is informative and can be properly used; statistical data indicate frequent visits, increasing in numbers year by year.
