on the activities of the National Institute of Criminology (OKRI) in 2019

I. UTILISATION OF RESEARCH RESULTS

We devoted considerable attention to the utilisation of our research results in this reporting period, too. Areas for the utilisation of results include cooperation in the development of theories and the presentation of research results in educational activities (in training courses for trainee prosecutors and junior prosecutors, in university and college education and postgraduate courses etc.), as well as at conferences and other professional events. Our researchers have published in and worked as editors or reviewers for several professional journals.

Their active involvement in scientific organisations is also of great importance. Our researchers who expressed their views in the media played an important role in informing the general public by presenting our results, approaches and opinions also in the course of the year under review as well.

1. Presentations

In 2019, researchers from the Institute delivered a total of **155 presentations** at various conferences and professional forums. Of these presentations, **9** were delivered **in a foreign language** and **8 were abroad**.

Requests **to chair sessions** also indicate professional recognition and presume professional skills. In the year of the report, researchers from the Institute were requested to chair sessions on **11 occasions**.

2. Publications

In the current year, researchers published a total of **69 publications**, **6 of them in a foreign language**. Of the latter, **4** were published **abroad**.

This year, OKRI's researchers published 11 chapters in books and 3 monographs (books, notes), and were authors of studies published in 31 scientific periodicals and 4 conference publications. In addition, 9 papers were published in the Institute's publications, as well as 4 studies on other platforms (abstract, beyond the website of the institute, other web interfaces etc.), and our colleagues were asked 7 times to edit various professional volumes. It is an increasingly characteristic phenomenon that some parts of professional periodicals are not published in a printed form: they are only available on the world wide web. It is therefore fortunate that researchers from the Institute also exploit the flexible publication opportunities provided by the internet.

II. DOMESTIC AND FOREIGN RELATIONS

1. OKRI's domestic relations

The Hungarian relations of the Institute were generally similar to those of previous years. The application of the focus group qualitative research methodology also strengthened our professional relations in the reporting year by virtue of establishing direct working relations with external professional operators.

We continued our professional cooperation with the Institute for Legal Studies at the Hungarian Academy of Sciences Centre for Social Sciences (MTA TK JTI), which started back in 2014. In this context, we organised a conference on 11th October in the reporting year titled 'The conceptual goals and the impacts of renewing the system of Hungarian criminal law'.

We also continued the institutional cooperation with the **National Office for the Judiciary** entered into in the previous year.

Once again, cooperation was the closest with the Prosecutor General's Office and with the prosecution system in general. The prosecution service initiated almost half (40%, 16 tasks) of all projects that were in progress during the year. Of the projects in the work plan, 7 were initiated by the Prosecutor

General's Office and 9 by county prosecutor's offices, and one research project was completed within the framework of a cooperation. Beyond the research completed as part of and in addition to the schedule, 4 additional tasks were completed on the basis of requests made by the Prosecutor General's Office.

As the representatives of the Prosecutor General's Office, we regularly attend the ordinary meetings of the Committee for the Classification of Sporting Events in Terms of Security and we participate in the electronic preparation of classification proposals during fast-track procedures; furthermore, we also regularly attend the meetings of the Security Committee of the Hungarian Football Federation.

During the reporting period, one of our researchers participated in the work of the Personality, Health and Emotional Control Research Group (formerly Criminal Psychology Research Group) of the ELTE Institute of Psychology, with special regard to its research on criminology.

Three of our colleagues were granted scholarships under the New National Excellence Programme.

Our researchers traditionally participate in the work of higher education institutions; many of them hold university positions.

Many researchers from the Institute perform other professional or public duties, partly relating to their educational activities. These include (but are not limited to) the following: directing doctoral schools, conducting courses in doctoral training, supervision of dissertations, supervision of PhD theses, acting as an opponent, acting as the chair of the jury at OTDK (national academic conferences of students), assessment of and consultation for students' academic conference papers and dissertations, assessment and writing of academic works submitted to competitions, consultation and commentary activities, etc.

In 2019, researchers participated in domestic conferences, round table or professional discussions on **147 occasions** where they delivered **presentations** on special request, and on a further **109 occasions** where they attended domestic and foreign conferences **without delivering a presentation.**

2. OKRI's international relations

International relations play an important role in the life of research institutes. International relations provide researchers with feedback, and they also help to evaluate OKRI's research activities, considering that invitations to take part in international projects, joint applications and offers to publish in renowned international academic journals all imply that the international scientific community appreciates the Institute's research activities and professional accomplishments.

In the reporting year, our researchers delivered a total of **155 presentations** at various conferences and events, of which **8** were delivered at conferences **held abroad.** Conference participations were covered in part by the Prosecutor General's Office, in part by researchers from grants and other funds, and the inviting parties also contributed to the costs.

The Institute is a research organisation with traditionally good international relations. One of the Institute's oldest and best functioning relations is with the **Max Planck Institute** in Freiburg, with which the exchange of experience and information and the organisation of joint conferences have been ongoing for decades. In addition, the MPI has received OKRI researchers *as grant holders* in many cases.

Our international relations are strengthened by the presence of our *foreign colleagues who visit us or deliver lectures or conduct research at the Institute*.

In May, the Institute received the *delegation of the Central European Police Academy*. In September, we *provided information to Ilaria Espozito, an OSCAD officer* (Observatory for Security against Acts of Discrimination/Osservatorio per la Sicurezza Contro gli Atti Discriminatori) on the situation regarding the prevention and punishment of hate crimes in Hungary.

One of our researchers participated in a three-day study trip in Bucharest, at the invitation of the CEPOL and EJTN organisations.

The Institute provided placements to two American students and one Transylvanian student in the reporting year (under the ERASMUS programme and the PPKE summer school).

III. LIBRARY

The library stock increased by 111 volumes in the reporting year, of which 56 were received as gifts or in exchange. Of the 111 volumes, 20 are in foreign languages, i.e. in English and German. The library stock currently consists of 9,480 inventory units.

The Hungarian Rules of Law in Force have also been available this year; they contain approximately 350 laws, the operative parts of 120 decisions and 100 opinions of the Supreme Court and the Curia, and short summaries of 120 decisions of the Competition Council in three languages. It also contains international conventions in English, and the journal entitled *Jogesetek Magyarázata* (Explanation of Cases) can also be accessed through this database.

Exchanges and gifts are important sources of enlarging our collection. We consider it important to maintain good relations with libraries collecting books from similar sources. Our exchange partners are the following: the libraries of the Max Planck Institute of Freiburg, Pázmány Péter Catholic

University, the Curia, the Faculty of Law Enforcement of the National University of Public Service, the Constitutional Court and the Office of the Commissioner for Fundamental Rights.

We also have a good relationship with the Library of the Hungarian Parliament, from where we continue to receive articles and studies relating to specified topics from the database of HeinOnline on a regular basis.

We continue with the libraries of the Prosecutor General's Office, the Budapest Prosecutor General's Office, the Office of the Commissioner for Fundamental Rights, the Hungarian Research Institute for Forensic Sciences, the Curia and the Faculty of Law Enforcement of the National University of Public Service to give mutual support to each other.

We strengthened our professional cooperation with the Library of the Prosecutor General's Office, since they transferred to using the *HunTéka* integrated library system also used by OKRI, which can be accessed through OKRI's server. This was achieved through a licence extension. Furthermore, this year too, it was our Library that carried out the selection of the literature for *Ügyészségi Szemle* (Prosecution Review), the peer-reviewed professional and academic journal of the Prosecutor General's Office, and it gave assistance to researchers on recording their MTMT data.
